- 2. 參加者必須年滿 16 歲並必須為中國香港柔道總會會員。
- 3. 参加者必須預繳註冊費,未能考獲資格者註冊費將獲發還。
- 4. 参加者必須同意提供本表格之資料作為是次申請之用途,並明瞭本表格及資料將會 於是次申請完成後自動銷毀。
- 5. 根據〔資料(私穩)條例第 18 條及第 22 條和附表 1 的第 6 原則〕,參加者有權查 閱及改正你的個人資料。
- 6. 参加者必須於結果公佈後一個月內,前往總會領取其證書。若以郵寄方式領証,將 不在此限。如參加者未能親身前來,亦可以書面授權他人代為領取。逾期者另收行 政手續費用港幣二佰元正。
- 7. 註冊費用為港幣一千元正。

## **REMARKS:**

- 1. This form is used for applicants who obtains Dan qualification not in Hong Kong and would like to apply for local Dan qualification. Applicants must show his/her official documents to the Association of Hong Kong, China to prove his Dan qualification.
- 2. The applicant must be over 16 years old and a member of the Judo Association of Hong Kong, China.
- 3. The applicants must pre-pay the application fee, the application fee will be refunded if the application is unsuccessful.
- 4. You must agree to provide the information included in the application form and understand that the form and information will be destroyed after the application.
- 5. You have a right of access and correction with respect to your personal data as provided for in Section 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance.
- 6. Applicants must obtain the certificate at our office no later than one month after the result announcement. It is not restricted if you are getting the certificate by post. If the applicant is not available personally, he/she may offer the other person to obtain by authorization. There will be an administration fee of \$200 for the late receiver.
- 7. The application fee will be \$1000.
